Dear Neighbours,

As we welcome the arrival of spring and prepare for the 2024 construction season, we hope this message finds you well.

Starting on **May 22, 2024** (weather permitting), we will begin road upgrades on 154 Avenue SW. As part of the project, a minor adjustment will be made to the current Detour Road #1. This adjustment will redirect traffic at the entrance to Alpine Park.

Throughout this process, we are committed to minimizing disruptions as much as possible by maintaining safe and accessible routes for all. For details on the adjustment to Detour Road #1, please refer to page 3.

Please remember to adhere to designated roadways and follow signage directions while traveling through Alpine Park. Avoid traveling near construction zones for your safety and the safety of others. Your support and understanding in prioritizing community safety are greatly appreciated, as safety is a shared responsibility.

Frequently Asked Questions

When is Detour Road #1 and this new adjustment scheduled to be decommissioned?

We plan to keep the current Detour Road #1 until the full build-out of the 154 Avenue upgrade is completed. This is expected to happen this fall, subject to weather conditions.

Does the adjustment affect traffic going in and out of the community?

No, the upcoming roadway adjustment will not impact traffic entering or exiting the community.
